FINDINGS OF FACT

- 1. Plaintiff, North Carolina Board of Examiners for Speech and Language Pathologists and Audiologists, is an agency of the State of North Carolina, created under the authority of Chapter 90 of the General Statutes of North Carolina. Plaintiff's principal office is located in Greensboro, Guilford County, North Carolina.
- 2. Defendant Kimberly Sade Guy ("Defendant") is a resident of Rock Hill, South Carolina.
- 3. Defendant is not now, and has never been, the holder of valid license to engage in the practice of speech and language pathology or audiology in North Carolina.
- 4. Defendant engaged in the practice of speech and language pathology or audiology in North Carolina, in violation of N.C. Gen. Stat. § 90-294(b), by holding herself out to be licensed speech and language pathologist.

2. Defendant has violated N.C. Gen. Stat. § 90-294(b).

3. Plaintiff is entitled to judgment by default.

Based upon the foregoing Findings of Fact and Conclusions of Law, it is hereby

ORDERED, ADJUDGED, and DECREED that:

I. Plaintiff's Motion for Default Judgment is hereby granted; and

II. Defendant is hereby permanently enjoined from the practice of speech and language

pathology or audiology in the State of North Carolina, until such time as she is licensed by

the Board.

III. That costs of this action be taxed against Defendant.
